## SECTION 1: FIRST LIGHT FLOWER ESSENCES OF NEW ZEALAND<sup>®</sup> REGISTERED PRACTITIONER CODE OF PRACTICE

A First Light Flower Essences of New Zealand<sup>®</sup> Registered Practitioner is expected to uphold, respect and maintain the good reputation of First Light Flower Essences of New Zealand<sup>®</sup> to the best of their ability by following these guidelines:

- To offer First Light Flower Essences of New Zealand<sup>®</sup> consultations and personalised First Light Flower Essences of New Zealand<sup>®</sup> blends to clients when requested in a professional context and in the best interests of the client.
- 2. To ensure consistency between the product and services that are offered or advertised by the Registered Practitioner and the products and services provided in practice.
- 3. To carry personal responsibility and accountability for their own practice and to maintain a professional stance at all times when conducting a consultation.
- 4. To treat clients and client records with absolute confidentiality and respect at all times.
- 5. To provide a safe, confidential environment for the consultation.
- 6. To refrain at all times from making claims to heal, cure or treat any conditions (emotional, physical, mental or spiritual). First Light Flower Essences of New Zealand<sup>®</sup> work at a vibrational level to help address the energetic cause of the many issues people experience today.
- 7. To professionally and respectfully manage and resolve any client complaints, ideally to the satisfaction of the client.
